

FOREST LAWN WEDDING PHOTOGRAPHY INFORMATION & AFFIRMATION

Couples are welcome to use the unique landscape at Forest Lawn as a backdrop for their wedding service and/or photography. No fee or permit is required for private wedding party photography.

Wedding couples, attendants, guests, and photographers must always bear in mind that Forest Lawn is private property, and that all visitors must strive to conduct themselves in a manner that does not disrupt cemetery operations or detract from the general dignity and solemnity of the cemetery. To ensure proper decorum with no disruption, we require all wedding parties to comply with the following rules:

- Photography must be accomplished during Forest Lawn's regular hours of operation. Arrangements will not be made for late or after-hours arrivals.
- Please wear appropriate attire when at the cemetery. Shirts and shoes are required. Any attire other than traditional wedding attire must be approved in advance by Forest Lawn.
- Any partial or total nudity is not permitted.
- Alcoholic beverages, and amplified music or sound are not permitted.
- Dogs or pets of any kind are not permitted.
- Throwing of rice or confetti on cemetery grounds is not permitted. Birdseed is permitted.
- No flammable items (fireworks, candles, etc.) are permitted on cemetery grounds. No lanterns may be lit or released on cemetery grounds. No guns, real or fake, with or without ammunition or blanks are permitted.
- Wedding parties may not block cemetery roadways or restrict other visitors from any area within the cemetery.
- No trash or debris may be deposited anywhere on cemetery grounds. All trash must be removed prior to departure or security will require removal.
- Parking on the grass is prohibited.
- Use of any area on cemetery grounds for wedding photography is on a first-come, first-served basis. Wedding parties must be considerate of other parties and not monopolize one area for an extended length of time.
- Please respect all monuments and memorials in the cemetery. Sitting upon, leaning on, or using a memorial or monument as a "prop" for photography is strictly prohibited.
