To Our Valued Funeral Directors and Families:

Here is the new Service Fee Schedule for the Forest Lawn Group (Forest Lawn, Lakeside, St. Matthew's, Williamsville, and Gethsemane cemeteries and Forest Lawn Cremation Company) which becomes effective February 1, 2022. A "Quick Reference Sheet" which lists our most common service fees is also included for your convenience.

As you review the new fee schedule, I call your attention to **several new benefits** for your families, who through heritage, or your efforts chose one of our cemeteries or crematory for final disposition:

- **We've lowered the Social Service burial fee by \$429 from the current fee. It is now \$900 with minor requirements.** See page 8 for details.
- **The Forest Lawn Chapel can be used for committal services or memorial services at NO CHARGE by:**
 - Forest Lawn lot owners or their direct heirs (when the interment is taking place at Forest Lawn or a Forest Lawn Group Cemetery)
 - Next of kin of a decedent who was cremated at the Forest Lawn Cremation Company**Note: we strongly encourage families to utilize a funeral director for all cremation services.**
- **A free online Memorial Page on the Forest Lawn website.** Here, family and friends can create a lasting tribute to their loved one by posting stories, photos, videos and other content. Now when your funeral home publishes an obituary for the decedent on your website, his/her memorial page will prominently feature the name, phone number and address of your funeral home.
- **Quick, convenient access to the Memorial Page through a unique QR code,** which is provided to the family on a wallet-sized plastic card, so they can simply scan the code with their smart phone and they will automatically be directed to their loved one's Memorial Page.
- **An "aftercare" program of text-based outreach** to the family to assist them with anything they may need following the loss of their loved one. The program includes access to grief support services. Note that we must secure the cell phone number of the next of kin to provide this service. We appreciate your help with this.

THE CEMETERY SERVICE FEES

EXPLAINED

The Cemetery's Service Fee is applied toward the cost of our basic services and overhead relating to the final disposition of the deceased, as well as the general care and operations of the cemetery.

The Service Fee includes:

- Use of the Cemetery's/Crematory's professional, staff, facilities, and equipment to respond to and complete the request for interment/entombment/inurnment or cremation services, as well as maintain the Cemetery/Crematory.
 - Upon completion of the service, entering all required information with the many duplicate permanent electronic and paper files, log books, registers and other documents.

In a Cemetery Interment / Entombment / Inurnment Service:

- Verification of ownership, right of burial privileges, and confirmation of permanent interment location.
 - Coordination between Cemetery administration and grounds with the funeral director and/or family members requesting and authorizing the burial service, securing and issuing necessary permits and authorizations for the service, preparation of the space for the burial, and restoration of that space following the service.

In a Cremation Service:

- Coordination between administration and certified crematory operators and the funeral director; securing and issuing necessary permits and authorizations for the cremation service.

**DELIVERY OF CREMATED REMAINS
TO FUNERAL HOME AT NO CHARGE.**

- Due to the NYS Department of Health guidelines, only essential crematory, cemetery and funeral home staff are allowed in the crematory at any time (public viewings are not allowed.)
- All U.S. Military veterans are honored with the use a very special veterans mailer that recognizes and pays tribute to the veteran for his/her service to our nation at no additional charge.
- The current NYS-mandated Cremation Authorization form must be signed and submitted before the cremation can take place.
- All battery-powered medical implants must be removed by a licensed funeral director or medical professional before cremation. Only wood or combustible caskets will be accepted.

EXPANDED BURIAL RIGHTS

**YOUR FAMILIES MAY HAVE A *FREE* GRAVE/CRYPT SPACE.
HERE'S HOW:**

In-Ground

We allow up to 4 burials in a single grave with no additional accommodation or “bury over” fees.

(1 casket and up to 3 cremation urns, or a total of 4 urns)

Please note: Standard interment fees would still apply.

The full body interment right cannot be used if more than one cremated body interment has already occurred in a single grave.

Above-Ground

We now allow 4 to 11 additional inurnments in crypts, depending on crypt configuration and caskets present with no additional accommodation or “bury over” fees.

Please note: Standard interment fees would still apply.

If a family you're serving has a direct heir (line of consanguinity) of someone who is the owner of burial space at any of the Forest Lawn Group of Cemeteries the members of the family may be entitled to a FREE burial space with their ancestor at that cemetery.

Please note that standard interment fees would still apply.

INTERMENTS

- A concrete or other permanent outer burial container is required except in situations of religious necessity.
- A 15 minute committal service by the Forest Lawn Group Chaplain if requested is also included. Learn more about this on page 12.
- Forest Lawn reserves the right to move a brief memorial service or committal service (15 minutes or less) from the site of the burial to a road side or an indoor venue of its choice, if in the cemetery's sole opinion, weather conditions or other circumstances make such a service at the site of the burial impractical.

DUAL INTERMENTS

When one or more cremated bodies are interred at the same time in the same location as one full body or one or more cremated bodies, a Dual Interment Fee will be charged for each additional cremated body, in addition to one regular Full Body or regular Cremation Interment Fee.

MEMORIAL & COMMITTAL SERVICES

Please note: As of the date of this publication, the chapel is NOT available for memorial/committal services due to COVID-related restrictions. As soon as the chapel becomes available, we will notify you.

The price for the general public's use of the Forest Lawn Chapel for a committal or memorial service for 2½ hours (see only available time slots below) is:

NEW: No charge for use of the Forest Lawn Chapel for all Forest Lawn Group Cemetery and Crematory Next of Kin.

We are now pleased to make the Forest Lawn Chapel available for extended committal (longer than 15 minutes) or memorial services at no charge to:

- Forest Lawn Group Cemetery lot owners or their direct heirs (when the interment is taking place at Forest Lawn or a Forest Lawn Group Cemetery). This includes lot owners at St. Matthew, Lakeside, Williamsville and Gethsemane Cemeteries.
- Next of kin of a decedent who was cremated at the Forest Lawn Cremation Company.

Chapel Reservation Times:

The Forest Lawn Chapel can be reserved for memorial or committal services in 2 1/2 hour increments, subject to the cemetery's approval on a first come, first-served basis.

The reservation times will be strictly managed to allow for clean-up of the facility by Forest Lawn staff between services.

The **only** available time slots are:

9:00 AM - 11:30 AM
12:00 PM - 2:30 PM
3:00 PM - 5:30 PM

No adjustment in the time slots are accepted.

MEMORIAL & COMMITTAL SERVICES

New Policies for Chapel Use:

Chaplain

- If a funeral professional is not present at the service, the Forest Lawn Group Chaplain must be present. Our Chaplain is available for services at any Forest Lawn Group cemetery at no charge to the family to facilitate a meaningful, cathartic and well-managed service.
- If a funeral professional is present and coordinating the service, the Forest Lawn Chaplain is NOT required. The funeral professional is then responsible to strictly adhere to the timeline for the service and other parameters.

Organist

- If an organist is requested, Forest Lawn has an approved organist(s) who must be used. Please note: The organ is a 1935 historic Wurlitzer pipe organ that was recently renovated by a benefactor, thus we only allow our approved organists to play this instrument.
- The family must contact the organist to review and select the music. The music selections for the service must be finalized at least 24 hours in advance of the service.

Refreshments

- No charge coffee, water and tea are available on a self-serve basis in the Peter and Susie Flickinger Reception room at the Chapel after the memorial service. Any time for refreshments must be taken within the two-hour timeframe for the service.
- **Please note that no outside food or beverages are allowed.**

FOUNDATIONS FOR MEMORIALS

Foundations for memorials must be constructed by the cemetery and conform to all the cemetery's Rules and Regulations. Orders for foundations for memorials shall be accepted only from Qualified Memorial Contractors, with written authorization by the lot owner or member of his/her family and submitted on an official foundation order form by a Qualified Memorial Contractor accompanied by an exact drawing and description of the proposed memorial. For details on these standards, refer to the Forest Lawn Groups Rules and Regulations - Article XII, pages 23-29.

If foundation plans call for form work or construction of niches or recesses for the placement of cremated remains, the construction shall be performed by the cemetery, or its designee/contractor at a fee based on the cemetery's cost for materials, equipment and labor.

DISINTERMENTS/DISENTOMBMENTS/DISINURNMENTS

The Cemetery requires that the family engage a licensed funeral director to be present and coordinate all disinterments /disentombments and may require a court order.

1. The cemetery reserves the right to schedule disinterments/disentombments/disinurnments at its convenience; based on weather conditions, other services scheduled, and burial location.
2. The fees herein relate only to the cemetery's opening and closing of the current interment/entombment/inurnment space (and, where appropriate, the reinterment/reentombment/reinurnment space).
3. The services of a professional vault company are required and must be coordinated through a funeral director. The service fees charged by a vault company or a funeral director in moving the outer case from the current space to the future space are **NOT INCLUDED** in the cemetery's fees below.
4. Duly executed authorization notarized forms are required in order to conduct a disinterment/disentombment/disinurnment. Contact the cemetery office to secure the required authorization forms. These forms are due a minimum of 5 business days prior to the requested service.
5. There will be an additional charge in the following instances:
 - a. Removal of existing lettering from a niche or crypt and preparation of the crypt or niche for future lettering.
 - b. Removal of a memorial and/or foundation from a grave.
 - c. Removal of the outer container from the cemetery by the vault company in the case of a disinterment (removal of casket from the ground) and reentombment (replacement of the casket into a crypt space).
6. An Ensuraseal will be required in the case of a disinterment (removal of casket from the ground) and reentombment (replacement of the casket into a crypt space), and the cemetery's current price will be charged to the customer.

INTERMENT OF CREMATED DOMESTIC PETS

Cremated domestic pets can be interred at all Forest Lawn Group cemeteries.

With the passage of New York State's Pet Burial Law in 2016, The Forest Lawn Group of Cemeteries has updated our Rules & Regulations, enabling our lot owners to inter their beloved cremated domestic pets in all of our cemeteries.

All fees for pet burials will be directed to the cemetery's permanent maintenance fund—helping us to keep our promise of perpetual care made to all those interred here.

Under this law, all fees associated with the burial of cremated domestic pets must be deposited into a "permanent maintenance fund." Therefore, any revenue derived from pet burials will go directly to the maintenance of the cemetery, which helps us to keep our sacred promise to provide the finest in perpetual care to all those who rest within our gates.

Because pet interments follow the same protocols as those for the burial of cremated human remains, the service fees are the same.

All interments are conducted with respect and dignity, and because the labor necessary to conduct a respectful and dignified interment service, to record the burial and vital statistics of the late domestic pet is the same — regardless if the interment is a deceased human or pet — our service fees for interment of cremated domestic pets are the same as the service fees for burial of cremated human remains.

CREMATED DOMESTIC PET INTERMENT FEE SCHEDULE

For an in-ground interment of a cremated domestic pet, the remains must be placed into a non-sealed urn vault to allow for future placement of cremated domestic pets in the same urn vault, consisting of concrete or another non-degradable material. The Interment or Inurnment Service includes the opening and closing of the grave or crypt, four folding chairs, artificial grass matting around the opening and over the mound of displaced earth of the grave, and may include a 15 minute committal service by the Forest Lawn Group Chaplain at no charge if requested. Escort available via Delaware entrance, Forest Lawn; Camp Rd. entrance, Lakeside; Clinton St. entrance, St. Matthew's; or Main St. entrance, Williamsville.
